A Juvenile Detention Officer that I supervise stated, she noticed juveniles have been able to better relate to others, developed an increased understanding of others, and have become more respectful since attending programming. These are just some of the positive outcomes I believe the program has offered.

In addition to the group forum sessions which are held at the detention center, My Brother's Keeper also provides one on one mentoring services. I feel this service would be very beneficial to many of the youth who leave the Brown County Juvenile Detention Center. I believe without positive role models and additional community resources it will be difficult for juveniles to continue moving in a positive, more productive direction.
